#### **Church and Community**

#### The Church

Gilead CP Church is located in a rural area of southern Illinois. Membership of the church is primarily based on people with generational ties to the area and conservative (not politically defined) belief foundation. The church has a history of involvement in community benevolence, a traditional worship style, and a membership consisting of retirees, small business owners, laborers, education, service workers, health profession and agriculture-related occupations. The church positions family values and traditional morals as central to a Christ-led life.

Church programming consists of worship service Sunday morning preceded by Sunday School, Service Sunday evening focused on topical or Bible study, and Wednesday evening service that includes a meal followed by study or devotion and corporate prayer. Focus of Sunday morning service is to reverently praise and worship via song, addressing prayer concerns of members and attendees, with sermons where scripture is made apparent. Our Sunday school focus is to strive for members increase in knowledge and understanding of God's word. Sunday evening would have the same goal. These times are designed to "grow" the church internally. Wednesday evening in addition to internal growth is an opportunity to address community needs/opportunities for Gilead to serve and/or to represent Christ and "grow" the church externally.

The church routinely (often as once per month) has a church-wide fellowship.

#### The Community

Gilead CP Church is located in a scenic rural area with an agrarian foundation. Johnson county is sparsely populated with Vienna, largest town in the county having a population of approximately 2000. Larger towns/cities nearby are Marion, IL, Paducah, KY and Cape Girardeau, MO all with populations of 20,000 to 40,000. Larger cities in closest proximity are Nashville, TN and St Louis, MO each approximately 2.5 hours' drive time. In addition to agriculturally related industries the opportunities for employment are service-related occupations, employment by three penitentiaries, health professions and education.

Gilead is located in an expansive national forest (Shawnee National Forest) that offers unique recreational opportunities. In general, the church and community would be defined as having values and interests aligned with blue-collar views: importance of family, friendships and children with fellowship and visiting being of primary importance. Pretense and stature are not highly regarded, but strong allegiance to community and country is prevalent. There is minimal diversity in the county and, therefore in the church. With this stated, prejudice would not be tolerated by the church and is not endemic to its culture. In a word the community would be described as traditional. The county has several churches with memberships and attendance less than 100 people. The larger churches in the county have attendance of less than 300. The population of Johnson county are not unaware of Jesus or the Bible, but rather not realizing the importance of worship and a personal relationship with Christ.

Primary denominations are mainstream protestant (Baptist, Methodist, Church of Christ, Pentecostal) and Catholic churches. There is a small population of Amish and larger population of Mennonite in the county. Johnson county does not have an ethnic heritage that is prominent in its culture.

#### **Church Programs**

Programs here at Gilead are primarily focused on fellowship/interaction of the church "family", making the church an essential component of members lives, and on needs of the surrounding community. Surrounding needs will include focus on individuals at crisis points (death of family member, hardship, health issue, etc.) and focus on opportunities for welfare and evangelism (weekend meal program for local elementary school, after school Bible-based teaching/evangelism program, community-wide vacation Bible school program, etc.). Mission program primarily supports a local center in the community aimed at evangelism and youth focus, support of specific people or programs involved in ministry and support of the Association. The church also commits to benevolence activities of members as needs arise. Community-based benevolence requests and support is accomplished by a county-wide program that Gilead CP Church supports.

#### **Current State of the Church**

Gilead CPC as most churches can be defined as pre- and post-Covid. Gilead stopped all services in mid-March and resumed in June. Prior to stopping services regular attendance was between 70 and 75 people. Attendance after reopening has been in the mid-thirties with potential attendance to be 40. Prior to stopping services, the church was growing, and visitors were common each Sunday. Potential for attendance and visibility of Gilead in the community is good. Wednesday services are seeing approximately 20 people with interest in returning to pre-Covid interest in corporate prayer and interaction. To deny the response to Covid has been detrimental to the church would be disingenuous. However, Gilead's position in the community is strong and Gilead's potential to grow beyond its pre-Covid reach is real and probable, with the right leadership.
