The Charleston Cumberland Presbyterian Church, Charleston, Tennessee, is searching for a Pastor to work with four active Elders and a membership of approximately and a congregation of approximately Our part-time pastor of fourteen years has retired from pastoral ministry effective June 30, 2021. We are a part of the Tennessee/Georgia Presbytery

We are primarily an "older" congregation, but have sufficient youth and children to keep us young! Our Elders and congregation are willing to follow good leadership, try new ministries, and help with the loving ministry of our church. We want to grow in spirit, service and numbers.

We are hoping to gain a pastor who will be on site Sunday morning and evening, Wednesday evenings, who will make contacts with church members through emails and telephone calls, and who will follow up and respond to prayer requests and make hospital visits when needed.

Our brick church building (built in 1982 with classrooms and a fellowship hall) and a manse sit on five acres atop a hill at the corner of Hwy 11 and the Access Road to I 75 (two minutes). Also, we continue to maintain our "Historic Cumberland Presbyterian Church" on Railroad Street in downtown Charleston. We are in close proximity to an elementary school and one of the three excellent high schools in Bradley County. Cleveland State Community College and Lee University are located nearby in Cleveland, Tennessee, and Tennessee Wesleyan University is close in Athens, Tennessee. Important local industries include Wacker, Olin Chemical and Resolute Forest. We are in close proximity to the Hiwassee and Ocoee Rivers, Cherokee National Forest and the Great Smoky Mountains National Park.

We are praying that God sends us a pastor who will serve our church AND our community. We would like to see our members be led to take more active parts in worship services as we do have members Who are quite talented, capable and anxious to serve and fellowship.
