## A. The Church and Community

## 1. The Church

Our church is a blend of 3-4 families that were involved with the church when it was first built. Over the years, children grew up and relocated and members moved but continued attending/. The church is unusual because most of the members do not live in the Mt. Pleasant area. The bond established over the years creates a very loving atmosphere and a caring community of believers. The church property has been maintained and its appearance to the general public would be welcoming. However the church is not located on Main Street. It is set back in a residential area of town.

## 2. The Community

The community would be considered a rural community. Over 50% of the children attending school are on free/r, educed lunch. Main Street consists of 2 relights, a few stores, and several places to grab a quick meal. There are several churches – (3) Baptist, (1) Methodist, (1) Presbyterian, (2) Church of Christ, and our Cumberland Presbyterian Church. There are a few businesses here but for the most part the town is made up of middle age-retired people. Some younger people have started moving into the community since houses are being built in this area. Mt Pleasant is ten minutes from Columbia which has a hospital, chain restaurants, and many businesses. The Columbia area is growing by leaps & bounds.

## B. Program Areas in the Life of the Church

Our church has a Worship, Christian Education, and Maintenance committee along with a very active CPWM. The committees meet as needed. The CPWM meets monthly. This group of ladies has been involved with many projects through the years from raising \$600 for cancer research to making pillowcase dresses for girls in Africa. This group has supported Faithworks (a community charity), along with a blessing box at our church for those in need.

# C. Worship Preferences

Our church is a traditional style of worship. We did not adapt very well to changes made by the last pastor but the changes did not go through the proper channels so being an older congregation we didn't accept the change very well.

# D. Goal, Objectives, Viewpoints

I am not aware of any goals or objectives listed for our church other than the goal Jesus established - to invite others to know Christ. The members are encouraged to invite people to Church frequently, a conscious effort to get more community awareness is definitely needed or this church will die within the next 5 years.

# E. Benevolence Support

OUO receives 10%; Presbytery Dues are paid by our Church. A Thank Offering is given every year at Thanksgiving to be placed in a general fund. Benevolence support is given to our local community charity – Faithworks. It supplies food, clothing to the needy of our community. Faithworks is supported by the Methodist Church. We keep a blessing box filled with food items to help those in need. We've been involved with the federal program – Meals on Wheels
